

NOTICE OF MODIFICATION ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53

THE NOTTINGHAMSHIRE (AREA 7) DEFINITIVE MAP AND STATEMENT

THE NOTTINGHAMSHIRE COUNTY COUNCIL  
(BILSTHORPE FOOTPATH NO. 19 AAND FOOTPATH NO. 20)  
MODIFICATION ORDER 2024

The above Order made on 3<sup>rd</sup> July 2024 under Section 53 of the Wildlife and Countryside Act 1981, if confirmed as made, will modify the Nottinghamshire County Council Definitive Map and Statement for the above Area by adding a footpath commencing from a point, SK 6508 5963 at the junction with Bilsthorpe Footpath No. 3 and proceeding for a distance of approximately 175 metres in a generally north westerly direction to a point, SK 6493 5972, and continuing for a distance of approximately 265 metres in a generally south westerly direction to a point SK 6469 5963 at the junction with Bilsthorpe Bridleway No.7, and by adding the footpath commencing from a point, SK 6493 5972, at the junction with Bilsthorpe Footpath No.19 and proceeding for a distance of approximately 385 metres in a generally northerly direction to a point, SK 6495 6013, at the junction with Bilsthorpe Bridleway No.7 as described in the Order and shown on the order map.

Copies of the Order and Map may be purchased from my Office at the address below at a cost of £5 per copy.

Any representations about or objections to the Order must be received by the Countryside Access Team at the address given below not later than 29<sup>th</sup> August 2024. Please state the grounds on which they are made.

If no such representations or objections are duly made to the Order, or any part of it, or if any so made are withdrawn, the Nottinghamshire County Council, instead of submitting the Order to the Secretary of State (or part of it if the Authority has by notice to the Secretary of State so elected under Paragraph 5 of Schedule 15 to the Wildlife & Countryside Act 1981) may itself confirm the Order (or that part of the Order) as an unopposed Order. If the Order is submitted to the Secretary of State for the Environment, (in whole or in part), any representations or objections which have been duly made and not withdrawn will be sent with it.
