HIGHWAYS ACT 1980

THE NOTTINGHAMSHIRE COUNTY COUNCIL
(ELSTON FOOTPATHS NOS. 16 AND 17)
DIVERSION ORDER (2024)

This Order is made by the Nottinghamshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the footpaths and the public it is expedient that the line of the paths should be diverted.

The Newark and Sherwood District Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public rights of way over the land situate at Elston and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation and certification of this Order.
2. There shall at the end of 7 days from the date of confirmation and certification of this Order be footpaths over the land situate at Elston described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.

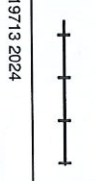
Elston Footpath Nos 16 and 17

OS Sheet No. SK74 NE

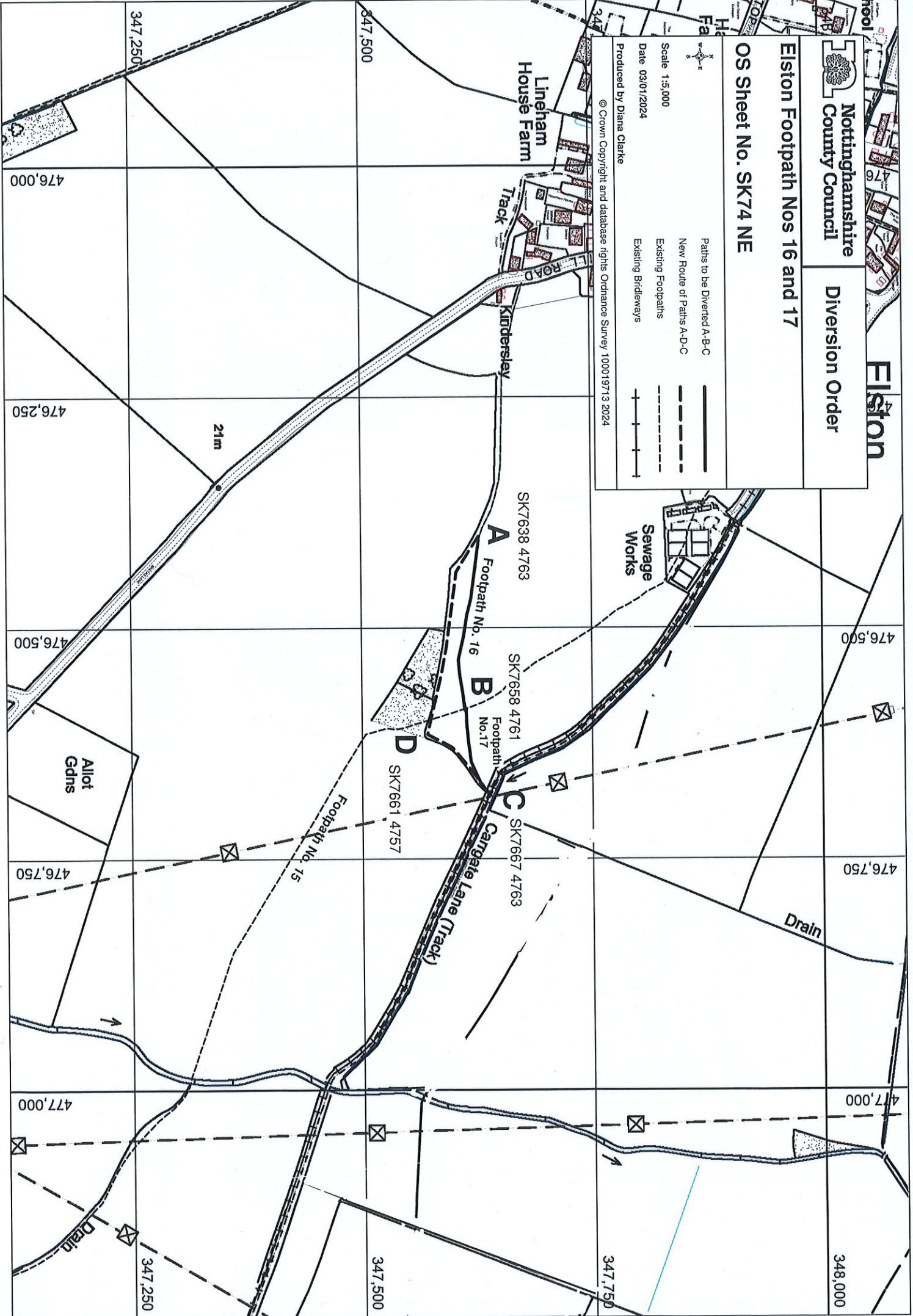


Paths to be Diverted A-B-C

SCHEDULE

PART 1

Description of Site of Existing Paths or Ways

Elston Footpath No. 16

The whole width of that part of Public Footpath No. 16 commencing at point A, (SK7638 4763), at the junction with the remainder of Footpath No. 16 and proceeding for a distance of approximately 190 metres in a generally easterly direction to point B (SK7658 4761), at the junction with Public Footpath No. 15.

Elston Footpath No. 17

The whole width of Public Footpath No. 17 commencing at point B, (SK7658 4761), at the junction with Footpath No. 15 and proceeding for a distance of approximately 100 metres in a generally easterly direction to point C (SK7667 4763) at the junction with Carrgate Lane.

PART 2

Description of Site of New Paths or Ways

Elston Footpath No. 16

Commencing at point A, (SK7638 4763), at the junction with the remainder of footpath no. 16 and proceeding for a distance of approximately 210 metres in an east-south-easterly direction to point D (SK7661 4757) at the junction with Public Footpath No. 15, having a width of 1.5 metres along the field edge on a grass and earth surface.

Elston Footpath No. 17

Commencing at point D (SK7661 4757) at the junction with Public Footpath No. 15 and proceeding for a distance of 110 metres in an east-south-easterly then generally north-easterly direction to Point C (SK7667 4763) at the junction with Carrgate Lane, having a width of 1.5 metres along the field edge on a grass and earth surface.
