

Further flexibility of the funding affords some local deviation from this timetable, e.g. stretched offer

NCC will pay a standard number of hours in each term so flexible approaches re start and finish dates are acceptable to enable children to access their funded hours. Settings can decide their own pattern of funded weeks using this document as a guide which should be communicated to parents, so they know about any unfunded days. There is flexibility in all terms on how the full allocation of funded hours can be offered by settings, i.e. there are unfunded weeks in spring and summer 2025 at the end of term where the funded entitlement can be used if a child starts a few days into term.

If any children on your headcount are leaving to start in a school nursery or reception class in September, PVI providers may not claim any funding in Autumn as all the funded hours will be allocated to school.

If a parent wishes to use any childcare in a PVI setting before starting school or school nursery, then they can expect to pay the PVI setting rather than use funded hours.

Each term we will pay out the funding to all providers on the basis of the maximum calculated hours per term (green and blue boxes above), unless you tell us your setting is open for fewer weeks than the standard weeks in the funded weeks timetable.
